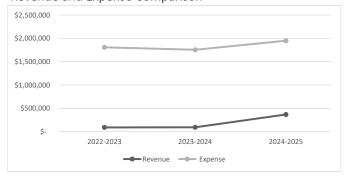

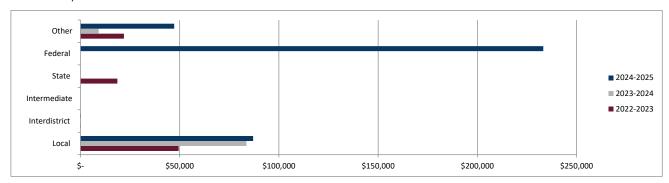

# Revenue and Expense Comparison

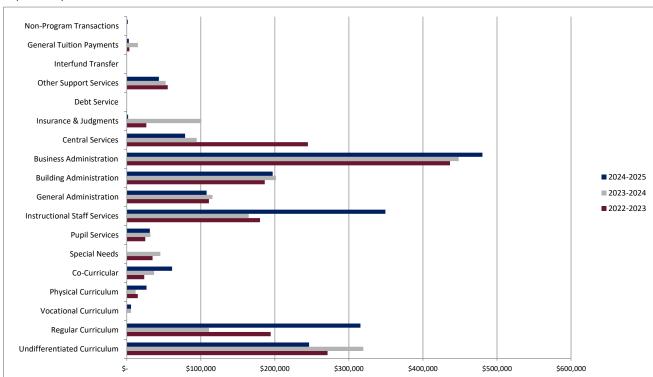
NET INCOME (LOSS)
